#### 1. INTRODUCTION

#### 2. HOW WE COLLECT YOUR PERSONAL INFORMATION

- 4.5. We may disclose your personal information in the following circumstances:

  - If we need to use such information to enforce our Terms and Conditions, or to protect the rights, property or safety of ourselves or others.
